



## SPORTS BYE-LAWS-FITNESS CENTRE



1. Persons using the fitness centre will enter their names in the register at the counter prior to using the facility.
2. Children less than 14 years of age are strictly forbidden to lift weights.
3. Members should be attired in proper sports gear, e.g. T-shirts, track-suits, shorts, sports shoes, etc., while using the facility.
4. Smoking and consumption of alcohol or other intoxicants are strictly prohibited inside the fitness centre.
5. Spectators are not allowed inside the facility.
6. Proper decorum while training should be maintained. Coach/Incharge reserves the right to expel the users for misbehaviour or for not observing the rules.
7. Members are not allowed to bring personal coaches/instructors inside the fitness centre.
8. Members causing deliberate damage to any equipment in the facility would be responsible for replacing/repairing the equipment at their cost/or a penalty of Rs.500/- would be imposed in the first instance. For subsequent such instances, the user can also be debarred from using the facility.
9. Members should take care of their personal belongings. Management shall not be responsible for any loss.

Pay & Play members	: -	Rs.400/-	(In addition to the Green fee Valid for the day of play only) (including GST)

Fees are subject to revision as decided by the management.

11. Guest must be accompanied by a member to use the facility. The member would be responsible for any misbehaviour/misconduct/inconvenience caused by the guest. Guest of the members will be charged Rs. 200/- per day.
12. Not more than 30 persons would be allowed to use the facility at any one time.
13. The management would not be held responsible for any injury/mishap caused to the user due to the use of facility.
14. Eatables are not permitted inside the fitness centre.
15. The fitness centre will remain closed on every Wednesday.

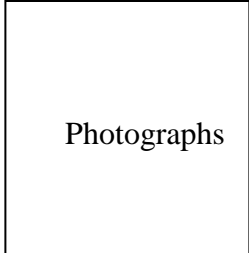
